A motion was made by Mike Venturini and supported by George Humphries Jr. to approve the 2019 Meeting Calendar. All in favor. Absent: Larry Jose. Motion carried.

David Steel made a motion to nominate Todd Shroats as Chair and Mike Venturini as Vice-Chair for the term of one (1) year. George Humphries Jr. supported the motion. All in favor. Absent: Larry Jose. Motion carried.
