

August 14, 2015 marked the **one-year anniversary** of the **incorporation of the City of Jonesville**. Much has been accomplished in these first twelve months toward the goals of incorporation, which included **consolidating** government services, **reducing** the property tax millage, and **governance by charter**.

Streamlined Services

Following incorporation, the City of Jonesville assumed responsibility for the following services, allowing residents, and business and property owners to receive all services from one unit of government:

- Elections
- Assessing
- Tax Collection
- Cemetery

The following summarizes some of the accomplishments in each of these areas this year. The document closes with comments regarding City budget and finances.

Elections

- Collaborated with Hillsdale County Clerk's Office to acquire election equipment at no cost
- Issued new voter identification cards
- Conducted the November 2014
 General Election and May 2015
 Special Election
- Installed a barrier-free ramp at the Fire Station
- ➤ Identified inactive voter records
- Approved a resolution maintaining even-year Council elections

Assessing

- Approved a short term agreement with the Hillsdale County Equalization Department for assessing services and conversion of records
- Implemented the BS&A Assessing Database Software
- Appointed a Board of Review and held March and July meetings
- Approved a contract with CSZ Services, LLC to provide City assessing services



Tax Collection

- 0.9011 mills of Township property tax was eliminated in the 2015 tax year
- Assumed responsibility for tax collection and disbursement to taxing jurisdictions

Cemetery

- Appointed a seven member Cemetery Committee to provide recommendations regarding maintenance and operation to City Council
- Adopted a Cemetery Ordinance and developed Rules and Regulations
- Updated the fee schedule
- Hired Baker's Lawn Care to provide contractual Sexton services
- Began clean up of brush and other yard debris that has accumulated
- Posted entry signs and installed avenue markers
- ➤ Identified future improvements in the five-year Capital Improvement Plan



Budget and Finance

- ➤ Fiscal Year 2015-16 Budget is balanced and provides adequate revenue and funding related to all new City services
- Accomplished an amicable division of Village taxpayer assets with Fayette Township
