

JONESVILLE CITY COUNCIL
Minutes of December 19, 2018

A meeting of the Jonesville City Council was held on Wednesday, December 19, 2018 at the Jonesville City Hall. Mayor Gerry Arno called the meeting to order at 6:30 p.m. Council members present were: Tim Bowman, Jerry Drake, Brenda Guyse, George Humphries Jr., Delesha Padula, and Andy Penrose.

Also present: Manager Gray, Attorney Thompson, Fire Chief Adair, DPW Supt. Kyser, Police Chief Lance, Treasurer Spahr, Julie Games, Christine Bowman, Kathy Humphries, Brett Hanlon (Redevelopment Ready Community Planner), Mark Nichols and Evans Mekas.

Mayor Arno led the Pledge of Allegiance and moment of silence.

The agenda was approved as presented.

Brett Hanlon, Regional Representative and Planner with Redevelopment Ready Communities Program, gave a brief presentation regarding the Baseline Report that has been prepared for Jonesville, along with recommendations for the sequencing of activities that the City will need to complete to achieve certification as a Redevelopment Ready Community.

A Public Hearing was opened at 6:53 p.m. for discussion of the proposed Ordinance No. 216, an amendment to the Zoning Ordinance that would establish regulations associated with Marihuana Establishments and the Sale and Consumption of Marihuana in Public Places. There was no public comment. The Public Hearing closed at 6:54 p.m.

A motion was made by Andy Penrose and supported by Jerry Drake to approve Ordinance No. 216 – An Ordinance to amend the Code of Ordinances of the City of Jonesville by adding a new article which new article shall be a new section which new section shall be designated as section 7-32 of Chapter 17 of said codes: Prohibition of marihuana establishments and: Section 15-2 of Chapter 15 said code: Prohibition on sale and consumption of marihuana in public places. Roll Call Vote: Ayes: Tim Bowman, Jerry Drake, Brenda Guyse, George Humphries Jr., Delesha Padula, Andy Penrose and Gerry Arno. Nays: None. Motion carried.

A motion was made by Jerry Drake and supported by Delesha Padula to approve Resolution 2018-15 – Implement Redevelopment Ready Communities Recommendations. Roll Call Vote: Ayes: Tim Bowman, Jerry Drake, Brenda Guyse, George Humphries Jr., Delesha Padula, Andy Penrose and Gerry Arno. Nays: None. Motion carried.

Delesha Padula made a motion and was supported by Brenda Guyse to appoint David Steel to the Zoning Board of Appeals to fill an unexpired term to end November 2020. All in favor. Motion carried.

A motion was made by Brenda Guyse and supported by Delesha Padula to approve the 2019 City Council Meeting Schedule. All in favor. Motion carried.

Manager Gray provided an update regarding Blue Care Network health insurance and Delta Dental insurance renewals for 2019.

A motion was made by Delesha Padula and supported by Andy Penrose to approve the Council minutes of November 21, 2018. All in favor. Motion carried.

Jerry Drake made a motion and was supported by Tim Bowman to approve the Council minutes of December 5, 2018. All in favor. Motion carried.

A motion was made by Andy Penrose and supported by Brenda Guyse to approve the Accounts Payable for December 2018 in the amount of \$98,739.91. All in favor. Motion carried.

Updates were given by Department Heads, Council Members and Manager Gray.
