Re: Supplemental Information – October 19, 2022 Council Meeting

I recommend that the agenda be amended to add the following items:

6. G. Resolution 2022-12 – Maumee Street Construction Contract [ROLL CALL][Action Item] You will recall that the Council approved a construction contract with the Michigan Department of Transportation (MDOT), for the milling and paving of Maumee Street from US-12 to Adrian Street, construction of a left turn lane adjacent to the elementary school south of Adrian Street, and replacement of several galvanized water services at the September meeting. The contract with MDOT is due to the \$415,602 in federal grants that will offset a significant portion of the project costs. At the time, the engineering estimate for the project was \$638,995.07.

MDOT opened bids on the project on October 7th. Four bids were received, with a low bid of \$646,073.42 from Michigan Paving and Materials. The low bid was \$7,087.35 (or 1.11%) over the estimate. This is a very competitive bid in the current construction and bidding environment from a company that the City is very familiar with. This addition would increase the City's share to just over 35% of the total project cost. There are sufficient funds in the Major Streets fund balance to proceed with the project. Staff recommends adoption of the attached resolution that would authorize the City Manager to execute an addendum to the contract with MDOT and other documents necessary to proceed with the project. *Please refer to the attached project bids and Resolution 2022-12*.
