## > The following is additional information regarding item 9.F. on the Council Agenda:

### 9. F. VoIP Telephone System

[Action Item]

The City Council budgeted for a Voice Over Internet Protocol (VoIP) phone system to replace the outdated copper-line system that currently serves all City facilities. Staff has received quotes from three providers. The low quote was received from Creek Enterprises, Inc., an IT services provider based in Adrian, MI. Although the equipment quote was slightly higher than their competitors, their ongoing service charges are considerably less. The overall cost of equipment and a three-year service agreement will be approximately \$6,000 less than the next closest quote. Overall costs for equipment and service charges for the three-year term will be just over \$19,000.

The current average monthly bill for City telephone services is just over \$1,000. The new service will cost a little more than \$400 per month, on average. The City expects to see a return on its investment for the equipment in just under 8 months, with ongoing operational savings after payback. I recommend a motion to enter into a three-year agreement for VoIP phone equipment and services for City facilities with Creek Enterprises, Inc. and authorize the City Manager to execute all necessary agreements.
