6. C. MDOT Signal Modernization Project

Staff has communicated with MDOT regarding the DDA action to approve expenditure for enhancements to traffic signals in conjunction with the 2019 planned project. MDOT staff have provided the attached drawings illustrating sample high visibility street signage. I have attached a mock up of the signage as it might appear on a mast arm.
