5. A. Financial Report

Attached is a revenue and expenditure report for the DDA through January 31st. The report shows revenue and expenditure activity for the month of January. It also illustrates the amount budgeted for each line item and the available balance in that line. Also attached is a report of the current cash balances in all accounts as of January 31st. I recommend a motion to accept the financial report. *Please refer to the attached revenue and expenditure report and cash balance report.*

6. A. Façade Grant Request – 245 E. Chicago Street (Jilly Beans Too)

The application for a façade grant related to planned improvements to Jilly Beans Too at 245 E. Chicago Street is attached. The work would replace storm damaged glass on the front façade and replace it with new windows, sills, and frames, including new paint. Stoll Construction has estimated the work at \$19,622. New signage and lighting would be added, as well; estimates for that work are pending. Grant program guidelines allow a grant of 10% of the qualifying costs, up to \$2,500. I recommend a motion to approve the grant in that amount. *Please refer to the attached application and cost estimate*.

6. B. City Tagline [Discussion/Action]

The City received many responses to the tagline contest, which are attached. This item is reserved for DDA discussion of the process to narrow and/or select a potential selection.
