I spoke to Jeff Wingard at Fleis and Vandenbrink about the second bidder for the sewer lining project. His office has attempted several contacts, but has not gotten a response from the second company that requested a bid package. They are not clear why they are not getting a response, but take it to mean that the company does not have a bid that was mailed/shipped but failed to be delivered.

If you clicked on the tracking in the email (below) from the one bid that we did receive, the delivery was to take place on February 8<sup>th</sup> (the day before the opening). Tracking shows it was delayed, causing it to be received after the bid opening time.




