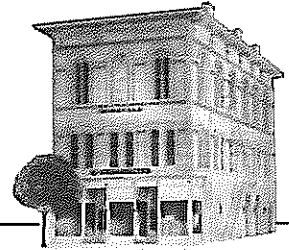

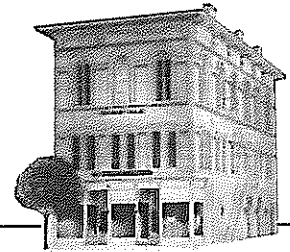

## **F.1 2014 Officer Selection –Chair, Vice-Chair, & Secretary**

The Planning Commission bylaws require the selection of officers at the regular meeting in January of each year. The Commission shall select from its membership, a Chair, Vice-Chair, and Secretary. Motions are necessary to nominate and select officers for 2014.

## **G.1 Medical Marihuana**

From the December meeting, there were questions related to enforcement of medical marihuana as a home occupation in the City of Grand Haven. Information regarding registration and enforcement in the City of Grand Haven will be available on the date of the January Planning Commission meeting. The proposed ordinance language provided by the municipal attorney originated from the Michigan Township Association. Additional information regarding this potential language will be available at the meeting. Finally, a map was generated to reflect enforcement of Drug Free School Zone in Jonesville. This would prohibit caregivers from operating within 1,000 feet of the property lines of schools and the Jonesville Community Library.

## **G.2 Recreation Master Plan**

From previous discussions, updating the Recreation Master Plan has become a high priority for the Village for the start of 2014. In order to be eligible for grant funds through the Michigan Department of Natural Resources, a current recreation master plan must be on file. The existing Joint Recreation Plan between the Village of Jonesville and Fayette Township expired on December 31, 2013. Had the Village of Jonesville not been awarded the DNR Trust Fund grant for development of the Rail-Trail project, getting the recreation plan updated and current would have been greatly expedited. However, because the grant was awarded, the sense of urgency is not as considerable.

From discussions with Fayette Township, they are willing to collaborate with the Village once again on updating the plan. Region 2 Planning Commission has provided the Village with a cost proposal for the Recreation Master Plan that we consider to be very reasonable. The next step is to form a committee that will work with Region 2 to develop the updated plan. Planning Commissioner Christine Bowman has agreed to represent the Planning Commission. Councilmember/Planning Commissioner Jerry Drake has agreed to represent the Village Council on the committee. Fayette Township will choose two representatives. Jonesville Community Schools will also have the opportunity to appoint a representative. Clerk/Recreation Director Means will serve as the Village representative on the committee. Village Manager Gray and I will provide administrative support to the committee.
