## 6. A. Transient/Short Term Lodging

[Action]

We have had passing conversations over the last several months about Airbnb and other forms of house sharing, where individuals permit short term stays in their single family homes. Chairman Venturini has offered some suggestions that we might consider for amendments to our Zoning Ordinance (see attached). I have prepared the attached summary of our current Zoning regulations. After meeting with Mr. Venturini, I recommend that we discuss the issue at our meeting to provide some general knowledge to the Planning Commission, then act to refer the matter to the Ordinance Subcommittee for review. *Please refer to the attached correspondence from Chairman Venturini and the summary of Zoning Regulations*.

## 6. B. Public Water System Operations
