3. A. Oath of Office

Staff will administer the Oath of Office to our newest member, Jim Ackerson. Mr. Ackerson was recommended for appointment by the Planning Commission, and subsequently appointed by Council, last month. His appointment fills the vacancy created when the Mayor's spot on the Planning Commission was made available to an at-large appointment.

7. A. Master Plan [Discussion]

As we gear up for the update to the Master Plan, staff has been in communication with Grant Baumann at the Region 2 Planning Commission to develop a scope for the updates, with potential Community Visioning facilitators, and with Dominic Romano at the Michigan Economic Development Corporation to interface with the State's Redevelopment Ready Communities program. I will provide an update at the meeting of the tentative scope and schedule for our update, and provide a bit of an orientation to the previous Master Plan. 7. B. Redevelopment Ready Communities Education Opportunity [Information]

The Redevelopment Ready Communities program is administered by the Michigan Economic Development Corporation (MEDC). It is a best practices evaluation to assure that communities have procedures and policies in place that will accomplish the development that the community desires.
