5. A. 1. Public Hearing: Ordinance No. 217 - Marihuana Establishments

This is the time reserved on the agenda for the purpose of receiving public comments on the proposed Ordinance No. 217, which would prohibit the establishment of Recreational Marihuana establishments and clarify existing regulations regarding Medical Marihuana Establishments.

5. A. 2. Action on Ordinance No. 217

[ROLL CALL] [Action Item]

Following the receipt of public comments, the Planning Commission may take action to approve, deny, or to postpone action on the Ordinance amendment to receive additional information.

At their December 19th meeting, the City Council acted to approve an amendment to the Code of Ordinances to prohibit the establishment of Recreational Marihuana facilities in the City, as well as the sale and consumption of marihuana in public places. It is the advice of legal counsel that, in addition to the amendment to the Code of Ordinances, the City should adopt a Zoning Ordinance Amendment to be clear that such land uses are not permitted within the City. The City Attorney has also recommended that this would be an appropriate time to add language to the Zoning Ordinance regarding Medical Marihuana facilities, as the City did not opt to permit such uses within the City.

If, at a later date, the City decides to opt in to permit either medical or recreational marihuana facilities, the ordinance may be amended or repealed. At this time, the State is still developing rules regarding the regulation of Recreational Marihuana facilities and many communities are adopting ordinances to prohibit facilities out of caution to first know what the regulatory landscape will look like.

The action of the Planning Commission will be a recommendation to the City Council. Council will also hold a public hearing on the amendment. I recommend the Planning Commission take up a motion to recommend that the City Council approve Ordinance No. 217. Approval of an Ordinance Amendment requires a roll call vote. *Please refer to the attached Ordinance No. 217 and Public Hearing Notice*.
