# Wright Street Park Public Input Session for the 2023-2027 Recreation Plan

The City of Jonesville Planning Commission invites all community members to attend a public input session to help with the updating of the city's Recreation Plan. This community event will be held \_\_\_\_\_ at Wright Street Park in Jonesville.

This community input session will include an overview of the city's recreation opportunities and the recreation plan process; informational maps of city facilities; staging areas to update parks and recreational goals and to make suggestions for implementation actions; and an opportunity to ask questions of Planning Commission members, provide input, and submit the City of Jonesville Parks & Recreation Survey.
